Although Ohio has 88 counties, their processes for changing a minor's last name share some steps. 1. Obtain a certified copy of the child's birth certificate.

The applicant for the name change of a minor must obtain the consent of the minor's parents, or notice of the hearing must be given to the non-consenting parent(s). Notice is usually given by Certified U.S. Mail (service available at any local post office) with the green card filed with the Court.

Name Change - Idaho

This section gives you information on legally changing your name or a minor's name by getting a court order. With a court order you can change your legal name on government-issued identification documents such as your driver's license, passport, and social security card. You will generally need a certified copy of the decree changing your name.

For the name change of a minor, a court hearing will usually be required. If there is a hearing, you must attend it. On the hearing date, the judge will hear any argument against your petition. If

the judge approves the name change, they will sign the Judgment for Change of Name of Minor Child (CAFC472).

When a change of name is completed, we amend the birth registration: for a child to include the change of name, but do not change the names of the parents; for an adult to show details of previously registered names and former names used. A deed of name change on behalf of a minor must be approved by the Senior Master on behalf of the Master of the Rolls who will take into account the child's best interests. A deed poll can also be used to change a child's name, as long as everyone with parental responsibility for the child consents to it [4] and the child does not object to it.

Name Change fees vary depending upon the number of persons named on the Order. Individual petitions must be submitted for each person and minor child, but only one order will be necessary.
